# **Privacy Policy for BarakaFi**

This Privacy Policy (the "Policy") describes the types of information that BarakaFi ("we," "us," or "our") may collect from you or that you may provide when you interact with BarakaFi's website and any products, materials and services provided by or on the website (the "Services"). This Policy also describes our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Policy applies to information we collect through the Services and your general use of the platform, including any interactions you may have with us through electronic communications, such as email. This Policy does not cover any information collected by third parties, including other applications or websites that you may access through the Services. # 1. Children Using or Accessing the Services

The Services are not intended for children under eighteen (18) years of age. We do not knowingly collect personally identifiable information from children under 18. If we learn that we have inadvertently collected personal information from a child under the age of 18, we will delete that information from our records. If you are under 18, please refrain from providing any information to us.

#### 3. Information We Collect

We receive several types of information about you from various sources, including (A) information you voluntarily provide and (B) information collected automatically through technology.

#### 3.1 Information and Content That You Provide

We collect personal information that you choose to disclose. This may include:

- **Personal Information:** Such as your name, address, email address, phone number, and wallet address, as well as any other details you provide when creating an account, completing forms, or engaging in transactions.

- JavaScript and HTML5 Local Storage: We use these technologies to improve site
  performance and track usage. Local storage allows us to store data in your browser
  to enhance your experience.

#### 4. How We Use Your Information

We use the information we collect in various ways, including:
